

1. Regulation on the number and type of pets(service animal)

- i) Dogs or cats are only allowed
- ii) Each passenger can bring only one pet per entry

2. The following two certificates must be taken along with owner and present to customs officer upon arrival

- i) Valid animal quarantine certificate issued by the official of the departing country or region
 - certificate being obtained via being processed with the animal health clinical examination by official institution 14 days prior to arrival at Chinese border
 - the certificate includes variety, scientific name, gender, hair color, date of birth or age, ID numbers+ date and site of the implanted chip; the clinical examination result and date of animal health
- ii) Rabies vaccination certificate

ATTENTIONS:

If the pets (service animal) do not meet the above numbers and types, OR cannot provide the official quarantine certificate or vaccination certificate, The pet(service animal) will be returned within a specified period or subject to destruction.

3. Pets(service animal) should be implanted with effective electronic chips

Electronic microchips must meet the international standards ISO11784 and 11785 (15-bit microchip code contains numbers only). If the chip does not meet the above standards, you should bring your own reader and writer that can read the implanted chip. For pets(service animal) that are not implanted with a valid microchip, a 30-day quarantine will be imposed upon entry.

4. On-site inspection by customs for pets(service animals) from 19 designated countries

In addition to meeting the above three requirements, pets entering from designated countries or regions may be exempt from quarantine and granted immediate entry upon passing on-site inspection.

Currently, the 19 designated countries or regions are:

New Zealand, Australia, Fiji, French Polynesia, Hawaii (USA), Guam (USA), Jamaica, Iceland, United Kingdom, Ireland, Liechtenstein, Cyprus, Portugal, Sweden, Switzerland, Japan, Singapore, Hong Kong (China), and Macao (China).

5. On-site inspection by customs and additional documentations for pets(service animals) from other than 19 designated countries

The rabies antibody test report issued by the laboratory which being endorsed by Chinese Customs (the antibody titer or the immune antibody volume must be above 0.5iu / ml), Pets that pass on-site inspection will exempt from quarantine and granted entry clearance. Those unable to provide the required certificates will be subject to a 30-day quarantine upon entry.

The laboratory located in Serbia whose test results are recognized and endorsed by Chinese Customs.

6. Pets(service animal) that do not meet the quarantine exemption requirements

For pets that do not meet the quarantine exemption requirements, entry must be made through ports equipped with quarantine facilities for inbound pets (as published by the General Administration of Customs). These pets will be quarantined for 30 days at a facility designated by Customs.

If entry is attempted through a port without such quarantine facilities, the pet will be subject to return within a specified period or disposal.

The list of ports equipped with quarantine facilities for inbound pets is:

- Beijing West Railway Station
- Beijing Capital International Airport
- Shanghai Pudong International Airport
- Shanghai International Cruise Terminal (Wusongkou)
- Shanghai Hongqiao Railway and International Airport
- Urumqi Diwopu International Airport
- Alashankou Port
- Guangzhou Baiyun International Airport
- Shanghai Railway Station

Notes:

- During the quarantine period, pets are, in principle, not allowed to be removed from the designated quarantine facility. If any abnormal health conditions arise, Customs will promptly notify the handler.
- Upon the handler's request, Customs may permit veterinary professionals to enter designated areas within the quarantine facility to provide treatment.
- If the required treatment cannot be performed within the quarantine facility, the pet may receive treatment at a qualified institution that meets both medical and Customs supervision requirements, with Customs overseeing the treatment process.

7. Entry of Guide Dogs and Search-and-Rescue Dogs

Guide dogs and search-and-rescue dogs brought into the country may be exempt from quarantine if they meet the following requirements:

They must have a valid official quarantine certificate, vaccination certificate, electronic microchip, and proof of specialized training. Upon passing on-site inspection, these dogs may be granted direct entry without quarantine. If only the vaccination certificate is missing, the handler may apply to have the dog vaccinated against rabies at a qualified institution.

Notes:

- Emotional support dogs are subject to the same entry and quarantine requirements as ordinary pet dogs.

4. Certificate Issuance and Collection

Upon passing the on-site quarantine inspection, Customs will issue the Animal Health Certificate as requested. The pet carrier or their representative shall collect the certificate in person at the Huangpu Customs Clearance Service Hall (黄浦海关通关服务大厅) at the notified time.
